



## 2019–2020 ENROLLMENT AGREEMENT

Thank you for choosing the White Mountain Waldorf School for your child’s education. **To secure your child’s place, please fill out the enrollment agreement AND return it to the office with at least half of the \$500 non-refundable deposit by April 30, 2019; \$250 per child due with agreement and the balance of \$250 per child due by June 1, 2019. Non-Refundable deposits are required for each child.** Deposits will be credited to tuition balance. Supplies fees are separate and are due by **July 1, 2019**. Tuition Insurance is mandatory and must be paid in full by **August 1, 2019**. The White Mountain Waldorf School partners with **Smart Tuition** for the processing and collection of tuition and fees. **Please go online to [enrollwithsmart.com](http://enrollwithsmart.com) to enroll and select your dates and payment plan.**

- \* Supplies Fee for Elementary include items needed for Main Lesson, Skills Blocks, and Specialty Classes
- \* Supplies Fee for Early Childhood/Kindergarten include items needed for the classroom and daily snacks

## White Mountain Waldorf School Enrollment and Tuition Policies

### Tuition Agreement

- I must have a tuition agreement filled out, signed, and on file before my child begins school. This is a legally binding contract. Tuition payments are due based on the date I select online with SMART Tuition to avoid late fees. (Initial) \_\_\_\_\_
- The school reserves the right for conditional enrollment. (Initial) \_\_\_\_\_
- I must have all proper forms filled out and on file before my child(ren) begins school. (Initial) \_\_\_\_\_
- Our family agrees to provide 36 hours of volunteer service or to pay \$500 extra. This will be billed on 12/1 and 6/1. (Initial) \_\_\_\_\_
- I have received and read the enclosed DEWAR Tuition Insurance brochure detailing the terms and conditions of coverage concerning this Plan. I understand that the Tuition Insurance is mandatory, to protect my yearly financial obligation under the terms of the Enrollment Agreement. This program insures tuition (prepaid and due) in the event of separation according to the terms of the policy. **Participation in DEWAR is required. Insurance will be billed separately.** (Initial) \_\_\_\_\_

**Tuition Policy:** Tuition payments must be made by the due date. *If tuition payments are more than 30 days past due, it will require an account review and could result in termination of the enrollment agreement. If payments or payment plans are not to date, re-enrollment and consideration for tuition aid will not be allowed. If the collections process is started, all applicable costs and fees are the sole responsibility of the undersigned financially responsible party.* (Initial) \_\_\_\_\_

If WMWS is unable for any reason to fulfill their obligations under this agreement, all monies paid towards next year's tuition and fees will be completely refunded.

In order to reserve a place for your child for the 2019-2020 school year, Enrollment Agreements and **\$500 non-refundable deposit toward your tuition balance must paid in full, \$250 per child when agreement is turned in by April 30, 2019 and the \$250 per child balance by June 1, 2019.** New families enrolling after this date will be handled on an individual basis based on availability. This agreement shall be interpreted in accordance with the laws of the State of New Hampshire. (Initial) \_\_\_\_\_

## SMART AID

White Mountain Waldorf School strives to make Waldorf education affordable to all families. Parents applying for **SMART AID** are asked to complete and submit the application online at [www.smartaidforparents.com](http://www.smartaidforparents.com) by **May 1st**. Late or incomplete applications will be considered only on a case by case basis. SMART AID will process the application and provide a report to our school. All information submitted will remain confidential and be given full and fair consideration by the Aid Committee. Applications completed and received by the deadline will be given first review and will be notified in writing by June 1st, if the application is approved and the amount of aid to be awarded. Aid is based on income and available funds.

Families who apply for Aid and don't receive enough financial assistance to afford tuition are always encouraged to write an appeal to the Finance Committee and/or may withdraw their child/children and request a refund for all monies paid toward the contract year, within one week of receiving of the award notification from WMWS.

- i. Should a family withdraw after more than 7 days have passed, the deposit will be forfeited.
- ii. Any payments received from families who have an outstanding balance (as of the date of withdrawal-from previous school years) will not be returned. Rather, the monies will be applied to the overdue balance.
